

Terms and Conditions

These terms and conditions apply to trip prize winner.

1. The trip prize:

- a. does not include insurance. It will be the responsibility of the prize winner (or their parents) to take out at their own cost all relevant insurance (including but not limited to health and travel insurance, insurance for theft, loss and damage to property) which may be required or prudent to obtain;
- b. consists of flights and accommodation only and does not include airport departure or government taxes, spending money, airport transfers or other expenses. These must be paid for by the prize winner;
- c. must be taken on the dates specified or the prize will lapse; and
- d. is also subject to the prize provider's terms and conditions, which will apply to the prize winner as well.

2. It is the responsibility of the prize winner to ensure their ability to travel to the trip destination and return home and, in particular, to:

- a. ensure that they have a valid passport endorsed with all relevant visas and with an expiry date no less than six (6) months following the proposed dates of travel or such other duration as may be required by any relevant regulation. The passport, and holder, must not be subject to any restrictions on their right to travel to and from the applicable country or countries. Passport control and in-country authorities may reserve the right to refuse entry to the prize winner;
- b. check any travel advisories issued by the Government and determine whether they wish to accept the risk of travelling to the trip prize destination;
- c. obtain any inoculation and comply with any health regulations required by the trip prize destination country; and
- d. comply with the terms and limitations of airlines, other transport providers, and the venues involved in the provision of the trip prize, including any insurance policy relating to the trip. In particular, entrants must comply with all health and safety guidelines and instructions and all applicable legal and regulatory requirements.

3. Gordon's School will not be responsible for any loss or damage suffered by the prize winner that arises out of their failure to arrive at the trip destination or return home from the trip destination, nor will we have any obligation to substitute an alternative prize, cash equivalent or other compensation where a prize winner is unable to travel to the trip destination or fails to redeem the trip prize for any reason.

1. The Red Letter Day Experience prize:

- a. does not include insurance. It will be the responsibility of the prize winner (or their parents) to take out at their own cost any relevant insurance which may be required or prudent to obtain;

b. consists of the Red Letter Day Experience only and does not include travel to and from the venue, spending money or other expenses. These must be paid for by the prize winner;

c. must be taken on the dates specified or the prize will lapse; and

d. is also subject to the prize provider's terms and conditions, which will apply to the prize winner as well.
