## The 1885 Bursary Fund


The Gordon Foundation and Gordon's School

General Charles George Gordon was killed on the steps of the Governor General's Palace in Khartoum in 1885. Within a year of his death, with the help of generous donations, the Gordon Boys' Home was established in his memory. The school that it subsequently became continues as his National Memorial of which Her Majesty The Queen is Patron.

Throughout his life General Gordon chose to live modestly, supporting the young and poor. As his National Memorial we strive to continue this philanthropic legacy with the provision of residential boarding bursaries to the young and disadvantaged of today.

*"If I had sons, I would certainly teach them a little of most trades, amongst others, bootmaking. You have no idea how feeble one feels not knowing these things... or a little carpentering, black-and-tin smithing, shoemaking and tailoring would be a real gift to a young man."*

## Modern ideas, traditional values

The Gordon Boys' Home was founded in 1885 for orphaned and disadvantaged boys.

Now a school built upon philanthropy; to this day we promote the values of Courtesy, Enthusiasm, Resilience, Integrity and Diligence.



## THE GORDON BOYS' HOME

**1885**

Established temporarily by the War Office in Fort Wallington, near Fareham, Hampshire.

**1887**

100 orphaned and necessitous lads march to West End from Brookwood Station led by their newly formed, twenty five strong Military Band.

**1887 – 1942**

Run strictly on military lines to instil discipline; boys are taught a range of practical trades, all with the purpose to set them up for a 'life of usefulness'.

## GORDON BOYS' SCHOOL

**1943 – 1989**

The Home makes a natural transition into a school, gradually phasing out vocational trades in the late 60s giving way to a broader educational syllabus.

## GORDON'S SCHOOL

**1990**

The first Gordon's girls arrive.

## TODAY

Gordon's School now stands as one of the most successful state boarding schools and sought after learning environments in the UK for boys and girls aged 11-18. With academy status and academically non-selective, it is one of the top 100 secondary schools within the UK. Ofsted rates Gordon's as Outstanding for both its teaching and learning as well as pastoral care.

## Why is there a need for a bursary campaign?

Gordon's, unlike many other charitable institutions, does not have major endowed funds to call upon. Currently, Gordon's offers financial support through means-tested bursaries to only a small percentage of the school population. The demand however is growing each year and we need to help as many children as we can.

We now look to our wider community and ask you to help Gordon's School help more disadvantaged children benefit from the rich ceremonial, academic, pastoral and philanthropic tradition by supporting The 1885 Bursary Fund.

## Campaign Target

The immediate goal is to raise £100,000 by September 2016 and £200,000 annually from 2017.

## Changing Lives

**W**illiam and Peter were supported at Gordon's as Weekly Boarders by generous bursaries. Their father died unexpectedly leaving the family with nothing. Their mother, a sole breadwinner, converted her mortgaged house and started a small B&B business to preserve the house as the family home. This she could not have done without residential boarding places and the financial support through bursaries.

**H**arry's father died leaving his mother with only the family home in a small village where his family had lived for generations. His mother worked in a very stressful job as a classroom assistant in a special school for children with severe educational and behavioural difficulties. Harry was supported at Gordon's as a Weekly Boarder with a Gordon's bursary. This enabled his mother to keep the home together for him and his brother which would not have been possible if, by having the boys at a day school, she had to seek other employment further away from her village home.

**G**eorge arrived at Gordon's with a Special Educational Needs Statement for emotional and behavioural difficulties and Attention Deficit Hyperactivity Disorder (ADHD). He had huge self-control and anger management problems coupled with extremely low self-esteem. Gordon's identified a latent musical ability; he had real talent for playing the flute. Over time, he became good enough to play solos in school concerts and went on to play in a concert at the Royal Albert Hall. The self-confidence he gained from music completely changed his outlook. He went on to achieve 10 pass grades A\* to C at GCSE, gained a place in the Sixth Form, and went on to university.

**N**icki and Adam were supported at Gordon's as Weekly Boarders by generous bursaries. Their mother was the sole breadwinner in the unreliable entertainment support industry. Their father abandoned them after years of violence and their step-father was wheelchair bound with MS and needed constant care. Weekly boarding was a family-saving salvation.

Of the current 740 pupils just over 200 are residential boarders; residential boarding can provide the pastoral, academic and extra-curricular opportunities and support a child needs, especially for those from a troubled background, providing the stability which allows children to develop confidence and achieve.

Social mobility is one of the key challenges of our society today. Gordon's has a long history of preparing the young to meet the challenges and expectations they will face in life.

Please help us to help more children from disadvantaged backgrounds have a life-changing Gordon's education.

Gordon's School is now a co-educational state boarding school, supported by The Gordon Foundation.

**8** people giving £1,885 will provide a full residential bursary for 1 year.


