Elon Musk's infamous Nazi salute at a rally celebrating Donald Trump's recent inauguration rightly caused outrage across the world. The gesture caused concern amongst people online, with many worried that this could point towards America drawing ever closer toward the far right.

Elon musk is unique as a businessman absolving himself in politics. However, he hasn't always been the power hungry fascist that people see him as today. In fact, he only began supporting primarily republican candidates in 2022, voting for Obama in 2008 and 2012, Hillary Clinton in 2016, and even Joe Biden in 2020. His acquisition of Twitter and hard pivot to right wing politics unfortunately fell around the same time, and he began taking advantage of the platform to spread misinformation. Even before he bought ownership of twitter, he would peddle falsehoods about the pandemic, claiming children were "essentially immune", and claiming there would be "probably close to zero new cases in US by end of April (2020)". In 2024, he fired the teams responsible for fact checking and moderating misinformation and reinstated accounts belonging to neo-Nazis and conspiracy theorists, such as Alex Jones (a far right radio host who has claimed for years that the Sandy Hook school shooting was a hoax). And as the most followed user too, nothing could stop him.

Musk also attempted to tamper with the 2024 election, with twitter posts casting doubt on mailed votes and electronic voting machines claiming "We should mandate paper ballots and in-person voting only". He also tried to dissuade voters in Arizona by criticising the state that doesn't require law proof of citizenship to vote in federal elections, despite the fact that if a non-citizen attempts to vote in Arizona they still face perjury charges (illegal voting). It's no coincidence that Arizona was a swing state in the election, and this was undoubtably an attempt to help Trump secure the state.





# Elon Musk: How Bad Could He Possibly Be?

Musk has repeatedly used his power and influence as a media mogul in order to politically interfere in favour of the right, but that's only online. Musk's actions as a new member of the American government are far more concerning.

Donald Trump and Musk created the Department of Government Efficiency on Trump' first day in office. This agency has access to "all unclassified agency records, software systems, and IT systems" of each department in the government.



As the leader of DOGE, Musk has cut government spending by firing thousand of federal workers, notably in the United States Agency for International Development (USAID) which is responsible for administering civilian foreign aid. His budget cuts are also reducing the workforce of the Environmental Protection Agency by 65%. The Department of Veterans Affairs could lose 76,000 employees, and Social Security Administration is looking at 12% cuts. DOGE has already lied about its savings, claiming that 105 billion dollars has already been saved despite budget experts easily spotting even the largest cuts aren't more than 10 billion dollars.



Last week at Trump's congressional address, representative Al Green of Texas was escorted out of the hall and has been censured (formally condemned) after heckling Trump, exclaiming that he had no right to cut Medicaid – a program that provides healthcare to underprivileged Americans.



However, AI can be useful as it allows for advancements in medicine, with applications in scanning for illnesses such as cancer. This has already been used with cases such as Sheila Tooth's, whose breast cancer was detected with AI at the University Hospitals Sussex. Using AI allowed people to be able to start treatment earlier, thus increasing their chance of survival. These AI 'readers' are able to detect what human eyes cannot. This presents a promising future for the application of AI within medicine: saving lives.

Furthermore, AI has been used by Surrey County Council to spot potholes and aid repairs using cameras attached to cars. This allows for further enhancements as it can see things such missing signs and overgrown as. foliage, and thus be able to flag them to be fixed. The council has explained how this would make the whole process of fixing the roads safer due to the highway inspectors not being needed to physically step into the road. This use of AI allows for progression in how road problems are sorted.

### Joint Enterprise and The Need for Reform By Jemima Robinson

Announced in October 2024 with the mitigating aim of abuse and undermining of the UK's criminal justice system, the parliamentary inquiry into Joint Enterprise is crucial for investigating its controversial use which allows someone to be charged with another person's crime. If it is believed that they foresaw it and intended to encourage or assist the direct participants of illegal activity, individuals could endure brutal and lengthy punishments, including prison sentences for convictions of murder, under our legal system. Do you believe it is fair and lawful for our justice system to hold people to account for crimes they did not directly commit?

question, Investigating this the Westminster Commission for Joint Enterprise, (launched by the newlyformed All-Parliamentary Group on Miscarriages of Justice and chaired by Labour MP Kim Johnson) aims to reform the law so that only those who make a 'significant contribution' to a crime are held criminally liable. Johnson argues that wrongful convictions of joint enterprise highlight serious dysfunction in the justice system, 'leading to devastating consequences for individuals, their families and their communities'.

Against joint enterprise are critics who believe it to be an unjust legal doctrine that punishes individuals who have little or no involvement in a crime. CONTRIBUTION, NO CONVICTION REFORM THE JOINT ENTERPRISE LAW

Many recognize the volatility of a law that bases convictions largely on foresight rather than direct intent or direct participation because it significantly lowers the threshold for guilt and results in unjust outcomes. For example, the 2016 Supreme Court ruling in R v Jogee acknowledged that the law had been misapplied for decades due to the heavy reliance on judicial discretion and interpretation.

Additionally, the disproportionate number of Black and minority ethnic defendants convicted under this doctrine raises concerns that racial profiling and discriminatory policing practices influence charging decisions. Campaign groups such as JENGbA (Joint Enterprise Not Guilty by Association) have highlighted cases where young Black men were convicted primarily due to associations, social media activity, or music preferences rather than concrete evidence of their involvement in a crime. Deviations in how judges treat joint enterprise has made the law highly controversial and problematic because it disregards evidence of an individual's direct participation in illegal activity and instead, places greater importance on whether judges believed an individual foresaw that an associate of theirs was likely to commit an offence.

Furthermore, is it fair for individuals to be found guilty of crimes and endure harsh sentences purely based on their association?

Many believe that joint enterprise undermines the principle of individual culpability by punishing individuals for the actions of others. Assigning guilt by than personal association rather responsibility creates instability within the legal system because association can be judged and interpreted in different ways.

For example, Joseph Appiah was just 16 when he was found to have killed another teenager and sentenced to 12 years behind bars. Despite, being 200 yards away when the fatal stabbing took place, he was convicted of murder under controversial joint enterprise laws and released 11 years later at the age of 25. This has caused existential problems for the rest of his life including difficulties in securing employment, having stable relationships and his identity in terms of how he views himself and how he viewed by society.

With Appiah and more than 1,000 suspects convicted of murder and manslaughter under joint enterprise between 2010 and 2020, it is arguable that the entire principle of Joint Enterprise is hugely problematic because it destabilises the UK's legal system; justice is frequently undermined when people are punished for crimes and given life-altering sentences simply because of their association.

However, despite these criticisms, some may argue that joint enterprise is a necessary legal tool for tackling serious crimes such as gang activity and violence. It forces accountability to be upheld in those who knowingly participate in criminal activity regardless of their lack of direct involvement. Arguably, without joint enterprise, it may be significantly harder to prosecute gang leaders and those who facilitate violent crimes from behind the scenes. As a deterrent, law enforcement agencies advocate joint enterprise as a vital mechanism pivotal in helping to discourage criminal activity by making individuals think twice before involving illegal themselves in potentially actions. Is it fair that people go unpunished for crimes they facilitated simply because they were not directly perpetrating illegal behaviour? Joint enterprise ensures that those who knowingly assist, encourage, or enable crimes cannot escape responsibility.

So how could Joint Enterprise be reformed to minimize its controversy? In response to increasing concerns about controversy, its the Westminster Commission is considering several reforms to address the flaws in joint enterprise law. A key area of reform they are exploring is based on Kim Johnson's bill which want to ensure that only those who make a 'significant contribution' to a crime are held criminally liable.

In cases where weak circumstantial evidence has been used to convict people under this law (such as Joseph Appiah), a 'significant contribution' reform would diminish unfair use of individuals the law where are punished with severe sentences merely because of their association however big or small.

A 'significant contribution' reform would also pressure the Prosecution to increase their burden of proof so that evidence presented leaves the jury without any doubt that someone could be convicted of a crime without their direct involvement. For example, if Prosecutors were required to demonstrate that the defendant was guilty of clear intent and active participation rather than relying on foresight alone, this would strengthen the restraints on joint enterprise so that its broad use would be limited to cases where evidence could support its principle of accountability. This would substantially reduce the risk of wrongful convictions by upholding fundamental constitutional ideals of a fair and lawful justice system that everyone can trust to protect their individual rights.

With such a staggering effect across the nation, where individuals and communities feel seriously let down and have lost faith in the law, the outcome of the inquiry is crucial for evolving joint enterprise into a legal principle that truly serves justice. While it is valid to consider joint enterprise as a vital mechanism for prosecuting serious crimes, its broad and deviated application has led to significant miscarriages of justice. For example, statistics from the Crown Prosecution Service reveal that black people are 16 times more likely to be prosecuted under the principle than white people and the sentencing of more than 1,000 people for murder and manslaughter under the law from 2010 to 2020 highly is dysfunctional.

To uphold the integrity of the legal system, a parliamentary inquiry is crucial for investigating potential misuse of the law where concerns of racial bias and injustice can be addressed and corrected to uphold the integrity of our legal system. Reforms proposed by the parliamentary inquiry, such as raising the burden of proof and addressing racial disparities, will vitally shape the nation's legal system so that it is fairer with a more just application of this law.

# **Trump: Why Is He Playing King?** By Ryan Hunter

Now that Donald Trump is beginning his second term, we're witnessing a flurry of executive orders—already reaching more than 73 within a span of months. The rapid-fire pace of these policy choices raises an intriguing question: Why is he doing it?

A probable explanation is that Trump is using executive orders to avoid legislative gridlock and public debate. His leadership style has never been discreet, and in the eyes of many of his supporters, that is what is required in a political climate where Congress

regularly bottlenecks key legislation. However, others worry that this increased reliance on executive action demonstrates a trend toward an unbalanced balance of power, where policy decisions are made with less and less input from elected representatives and the public.

But historical context is important here, Trump's approach is similar to those leaders who have attempted to consolidate power through executive rather legislative action than negotiation. For example: Franklin D. Roosevelt, whom Trump has often invoked, issued 3,721 executive orders in four terms, using them to bypass opposition during the Great Depression and in World War II. But Trump is not facing a crisis on that scale, which raises questions about whether such an approach is truly necessary or merely a demonstration of power.



Another possibility is that Trump is deliberately asserting his authority, sending the message that he is the one who can bring fundamental change. Executive orders allow him to bypass a frequently obstructive Congress, even when his party is in control. While many presidents have used executive actions in the name of efficiency, the sheer volume of Trump's orders suggests a broader shift in governing style-one that emphasizes one-sided decisionmaking over bargaining and negotiation. His stance on foreign policy also illustrates this desire to show strength. In a recent call with Ukrainian President Volodymyr Zelensky, Trump reportedly declared, "This war would have been over in three days without us." While some may regard such a statement as evidence of leadership, critics argue that it harms diplomatic relationships and betrays a transactional approach to international conflict.

Aside from executive orders, Trump has placed the opioid crisis-more particularly fentanyl-high among his talking points. Fentanyl-involved deaths in the U.S. grew 279% between 2016 and 2021, and thus it is certainly a legitimate crisis that necessitates action. However, domestic instead of focusing on healthcare reform and rehabilitation initiatives, much of Trump's apologia is aimed at China and Mexico, framing the crisis in the narrative of foreign menace rather than as a structural issue.

Though it is true that fentanyl is trafficked across borders, critics say blaming foreign countries is an oversimplification of the crisis. It will take policy solutions at home to address addiction to drugs, such as better mental health services, tighter pharmaceutical controls, and more money for rehab programs.

Public response in America to Trump's executive orders has been mixed. On the one hand, many of his supporters view the flurry of executive activity as a justified assertion of authority—a way of circumventing political gridlock and implementing his agenda. A 2018 Gallup


survey showed that 45% of Americans approved of Trump's handling of the economy—his central reasoning for signing so many of these orders. His supporters argue that swift action on immigration and healthcare matters shows a commitment to fulfilling his campaign promises.

critics However. have cautioned concerning eroding democratic norms. By a 2020 Pew Research analysis, 60% of Americans were concerned about the growing centralization of power in the presidency, seeing it as a threat to the equilibrium of government. Public opinion has also been divided over Trump's foreign policy, especially his unilateralism on international matters. Many Americans have questioned the judgment of a president who appears to see diplomacy as a tool of selfadvertisement rather than multilateral cooperation.

#### What Comes Next?

Trump's increasing reliance on executive action raises serious questions about the balance of power in American democracy. While some see his approach as a necessary response to political gridlock, others fear that it sets a precedent for governing that limits checks and balances. If the trend continues, the United States can expect a fundamental shift in the exercise of power-one in which executive power is under fewer constraints.

The real question is: Do Americans see this as efficiency, or as a step toward an unchecked presidency?



# Baz Luhrmann's Romeo and Juliet: How Fashion Enhanced A Tale As Old As Time

Whether you have watched the classic film, or not, Baz Luhrmann's 1996 rendition of Shakespeare's Romeo and Juliet remains one of the most recognisable films in popular culture. The movie takes a classic love story and tells it through a kaleidoscopic lens, it is an almost hallucinogenic re-telling of a tail as old as time.

Costume designer for the film, Kym Barret, met Luhrmann through their background shared in theatre. This theatre background serves as the key ingredient to the distinctive costuming, as job delineations are typically far less rigid than in film, creating a cohesive feel that Barret said was brought to set. Taking a classic play with as many previous interpretations as Romeo and Juliet has and making it drastically distinctive meant starting with a clean slate and returning to the drawing board when sourcing inspiration. Barret and Luhrmann took to the streets of Miami, making video vinaigrettes, drawing inspiration from the surfers, beach goers and tourists. When speaking to British Vogue in 2021 for the 25th anniversary of the film, Barret stated that "Shakespeare isn't a normal medium for film. I think we needed to be really solid with the vision and really tight, so that all the visuals supported the language and people could relax into it and understand what was happening."




Costume being used to support language is evident repeatedly during the film, predominantly during the ballroom party where our two starcrossed lovers meet. With a budget of only \$15 million. much of the costumes were handmade by a team of seamstresses flown into Mexico City from Montreal and Italy. Barret also struck up a deal with Dolce & Gabbanna, Prada, and Yves Saint Laurent who pulled old stock that the team could use. Barret populated the ballroom scene with Shakespeare characters to tell stories in themselves of the two families. "Lord Capulet is a Roman emperor and Lady Capulet is Cleopatra. Then Paul Rudd as Paris is a bit on the outside, and a bit of a space cadet, so an astronaut felt right. I always thought of him as floating out a bit beyond reality."

As the ballroom scene bleeds into Juliet on the balcony, we see Claire Danes in a white wedding-gown-like dress. Barret printed written lines from the script onto the dress. "Romeo says in the script, 'Oh, speak again, bright angel,' which is why I dressed her as an angel, but I also printed that dialogue from that scene into her dress with white print". Costuming from the film has had a lasting impact within popular culture, with Juliet's angel costume becoming a popular Halloween costume, as well as Romeo's wedding suit. For this outfit, Barret called Ms Miuccia Prada who agreed to make him a suit.

Barret creates a stark contrast between the design of the Capulet and Montague costumes in order to "serve the characters and [make] them memorable." She came up with the idea of ornate, bulletproof waist vests for the Capulet family, saying she wanted them to have a "kind of gunslinging, gangster, low-hipped, cowboy-boots kind of vibe." The designer pulled these items from old Dolce stock which in her words "we were able to bastardise some things – we chopped the sleeves off, or we over-dyed them to age them or the capulate of the stock where a stock wher

threw dirt on them."

On the contrary, the Montague family "are more flyboy. They're like the guys in Hawaii that leave from the ship. They're still fighters, but they're more laidback and relaxed and American in a way." For their costumes, Barret painted catholic iconography onto Hawaiian shirts with a dreamy, romantic Technicolour motif that she found at a Miami thrift store, using Leo's shirt that he wears in the cathedral at the end as the jumping-off point for the rest. The design team painted onto one of Leo's shirts, a bleeding heart and death lilies that acted as a foreshadowing for what was to happen.



This film provided the MTV Generation with a post-modern view of a classic tale, having a lasting impact on pop culture and the way we view Shakespeare. From its iconic soundtrack featuring songs by Radiohead, Garbage, and The Cardigans, to its perfect costuming down to the minute detail, this film is a must watch.

# *LITERARY REVIEW* The Midnight Library








#### **One life**
